- You must submit new work. We will not accept courses that have been submitted to any of iSpring's previous contests.

- You can publish your course in iSpring Cloud to deliver it to us via a link. Your course also can be published in HTML5 or PPT and you must submit a file containing all the resources (this can be from an archive).
- The winners will be selected by eLearning experts. The first three place awards will be conferred upon the authors of the courses that have scored the most points according to the judges. The audience award will go to the person who has the highest number of reactions to their course on their social media. The winners of other nominations will be selected by the judges.
- The judging criteria are: Educational approach, Interactivity, Navigation, Design, Originality, and compliance with the iSpring Championship terms and conditions.
- All courses submitted must include:
 - 1. 12-25 slides
 - 2. An intro slide with a description of the course
 - 3. A quiz with at least one drag-and-drop question
 - 4. An interaction
